THE PARTNERSHIP ACT (Alberta)**





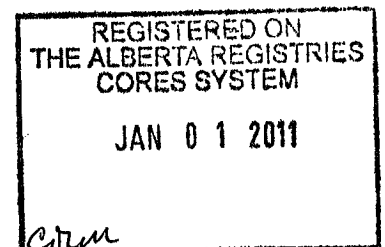
